## ELECTORAL ACT 1907

**DIVISION OF THE STATE INTO ELECTORAL REGIONS AND  
DISTRICTS BY THE ELECTORAL DISTRIBUTION  
COMMISSIONERS FOR THE NEXT STATE GENERAL ELECTION**

This notice divides the State of Western Australia into electoral regions and districts for the purpose of State Parliamentary elections and representation.

By virtue of the publication of this notice in the *Government Gazette*, the notice takes effect and has the force of law and applies in respect of elections in Legislative Council regions and Legislative Assembly districts held after the date of publication of this notice, but not before the next State general election.

The average district enrolment as at the close of the State electoral roll on the relevant day, namely 11 March 2019, was 27,573.

The Commissioners made decisions about the changes that would be necessary to district and regions boundaries by reference to the numerical limits imposed by Section 16G of the *Electoral Act 1907* (the Act) and after giving due consideration to the factors listed in Section 16I of the Act. The Commissioners reasons for making their decisions are available on the WA Electoral Boundaries website at [www.boundaries.wa.gov.au](http://www.boundaries.wa.gov.au) in both the proposals and final reports.

Having made those decisions, the Commissioners—

- (a) identified the precise boundaries of regions and districts by reference to a combination of the matters set out in Section 16F(5A);
- (b) caused those boundaries to be recorded in digital or electronic form so as to permit the creation of digital, electronic and printed versions of the maps showing the boundaries of each region and district; and
- (c) lodged those versions of the maps, which are identified as Deposited Plans 418163-418227, with the Land Information Authority (Landgate) pursuant to Section 16MA(1) of the Act.

This notice includes print versions of six of the 65 digital maps lodged with Landgate, namely, Deposited Plans 418163, 418168, 418173, 418182, 418197 and 418212. These maps depict the boundaries of the six Legislative Council regions and their constituent Legislative Assembly districts, including the name assigned to each district.

This notice also includes Table 1 which sets out the name of each region and its constituent districts, the total number of electors (including the Large District Allowance (LDA) where applicable) as at 11 March 2019 within the boundaries fixed for each region and district, and the corresponding Deposited Plan number for each.

For the purposes of Sections 16F(4)(b)(ii), 16F(5A)(b) and 16MA(2), the electronic version of the maps lodged with Landgate under Section 16MA(1) describes the boundaries fixed for each district.

In any proceedings, the deposited plans lodged with Landgate are evidence of the boundaries of the regions and districts fixed under this notice.

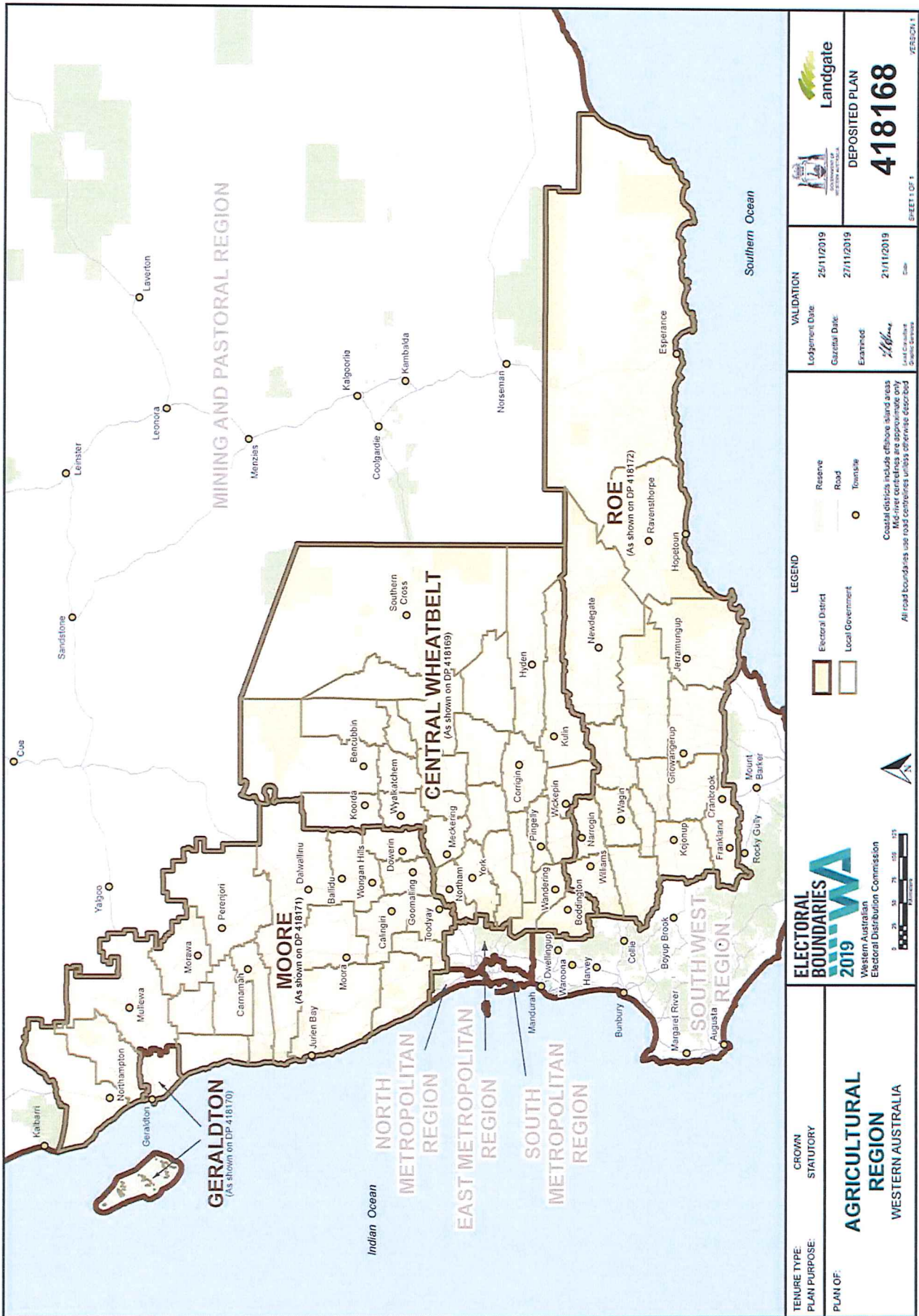

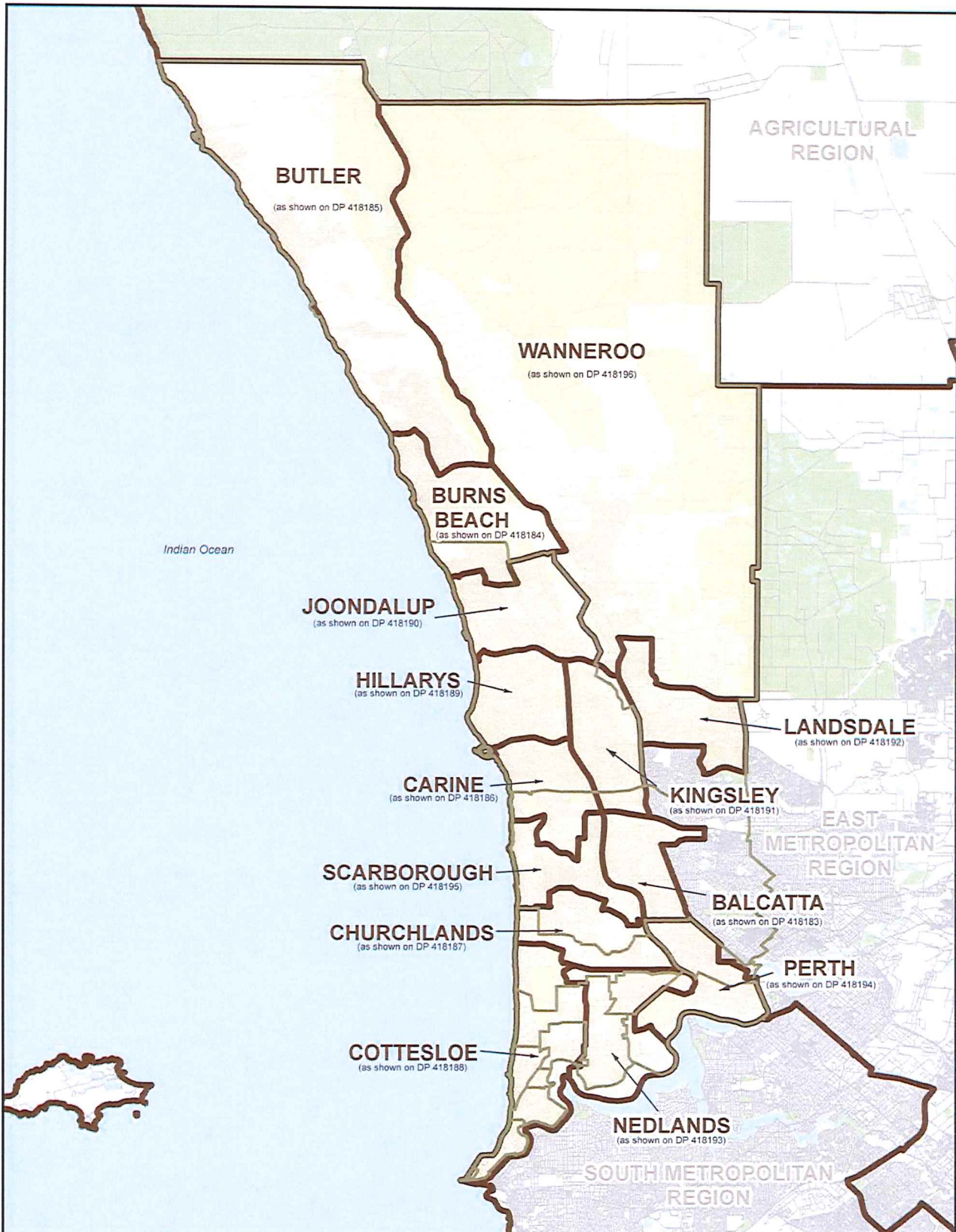
