

# **Electoral District Boundaries Technical Descriptions**

**10 October 2011**

### OVERVIEW

For ease of reading, the following technical descriptions have been prepared in numbered paragraphs and sub-paragraphs for each district. Each paragraph describes an area of land forming the whole or part of the district boundary and each sub-paragraph describes part of the detail of that area of land.

All references to local government boundaries require access to the appropriate issue of the *Government Gazette* in order to obtain the technical description of the respective boundaries. The Municipality Boundary Amendments Register is a separate publication prepared to facilitate the identification of the appropriate issue of the *Government Gazette*.

Please refer to the addendum of this publication for more information. Where local government boundaries are used and these boundaries do not extend to the low water mark; the area of land between this mark and the high water mark is included in the respective State electoral districts.

## TECHNICAL DESCRIPTIONS

State Electoral District of  
**Albany**  
SOUTH WEST REGION

All that portion of land bounded by lines:

- 1) Comprising the local government area of the City of Albany.
- 2) Including adjacent islands and the adjacent land between high and low water mark of the Southern Ocean.

State Electoral District of  
**Alfred Cove**  
SOUTH METROPOLITAN REGION

All that portion of land bounded by lines:

- 1.1) Commencing at the intersection of the centre line of the Swan River with the prolongation northerly of the centre line of Petra Street, a present north-western corner of the Town of East Fremantle and extending southerly to and along that centre line to the centre line of Canning Highway.
- 1.2) Thence generally north-easterly along that centre line to the centre line of Stock Road.
- 1.3) Thence generally southerly along that centre line to the prolongation westerly of the centre line of Kitchener Road.
- 1.4) Thence easterly to and along that centre line to the centre line of Norma Road.
- 1.5) Thence southerly along that centre line to the centre line of Marmion Street.
- 1.6) Thence generally easterly, generally north-easterly and generally south-easterly along that centre line and onwards to the centre line of Riseley Street.
- 1.7) Thence north-easterly along that centre line to the prolongation westerly of the centre line of Davenport Road.
- 1.8) Thence easterly to and generally easterly, generally south-easterly and easterly along that centre line and onwards to the centre line of Rogerson Road.
- 1.9) Thence southerly along that centre line and onwards to the centre line of Canning Avenue.
- 1.10) Thence generally north-easterly, generally easterly and again generally north-easterly along that centre line and onwards to the centre line of the Canning River.
- 1.11) Thence generally north-westerly downwards along that centre line and onwards to the prolongation westerly of the centre line of Thelma Street.
- 1.12) Thence westerly along that prolongation to the centre line of the Swan River.
- 1.13) Thence generally south-westerly, generally north-westerly, again generally south-westerly, generally south-easterly and again generally south-westerly downwards along that centre line to the starting point.

State Electoral District of  
**Armadale**  
EAST METROPOLITAN REGION

All that portion of land bounded by lines:

1.1) Commencing at the intersection of a north-eastern side of Ranford Road with the centre line of Tonkin Highway (undedicated), the present southernmost southern corner of the City of Gosnells and extending generally north-easterly, south-easterly, south-westerly and north-easterly along the common boundaries of the Cities of Armadale and Gosnells and onwards to the centre line of the Canning River.

1.2) Thence generally south-easterly, generally south-westerly, again generally south-easterly and generally north-easterly upwards along that centre line to the prolongation north-westerly of the centre line of an unnamed road passing along the south-western boundary of Lot 9, as shown on Diagram 27168.

1.3) Thence south-easterly to and along that centre line and onwards to the centre line of Hill Street.

1.4) Thence easterly along that centre line to the prolongation northerly of the centre line of Paterson Road.

1.5) Thence southerly to and along that centre line to the prolongation westerly of the northern boundary of Lot 13, as shown on Diagram 46721.

1.6) Thence easterly to and easterly and south-easterly along the northern and north-eastern boundaries of that lot and south-easterly along the south-western boundary of Lot 512, as shown on Diagram 93868 to the northernmost north-western boundary of Lot 202, as shown on Diagram 67108.

1.7) Thence south-westerly along that boundary and onwards to the centre line of Paterson Road.

1.8) Thence south-easterly and south-westerly along that centre line to the prolongation north-westerly of the southernmost south-western boundary of Lot 202, as shown on Diagram 67108.

1.9) Thence south-easterly to and along that boundary and onwards to the centre line of Canns Road.

1.10) Thence generally south-westerly along that centre line and onwards to the centre line of Carradine Road.

1.11) Thence generally south-westerly, south-easterly and again generally south-westerly along that centre line and onwards to the centre line of Albany Highway.

1.12) Thence generally north-easterly, generally south-easterly, generally southerly, generally south-westerly and again generally south-easterly along that centre line to the prolongation north-easterly of the north-western boundary of Lot 1, as shown on Diagram 1062.

1.13) Thence south-westerly to and along that boundary to the northern corner of Lot 803 as shown on Deposited Plan 38366.

1.14) Thence south-westerly along the north-western boundary of that lot to the northernmost south-eastern corner of Lot 2 as shown on Diagram 91097.

1.15) Thence generally south-westerly and north-westerly along south-eastern and south-western boundaries of that lot to the south-eastern corner of Lot 1, as shown on Diagram 16592.

1.16) Thence north-westerly along the south-western boundary of that lot and onwards to the centre line of South Western Highway.

1.17) Thence generally south-westerly and south-easterly along that centre line to the prolongation north-easterly of the centre line of Stone Street.

1.18) Thence south-westerly to and generally south-westerly along that centre line to a north-eastern boundary of Lot 401, as shown on Deposited Plan 32619.

1.19) Thence south-easterly, south-westerly, northerly and again south-westerly along boundaries of that lot and south-westerly along the south-eastern boundary of Lot 1167 (Reserve 22556-Railways), as shown on Plan 796 (sheet 10) to the centre line of the Perth to Bunbury Railway.

1.20) Thence generally southerly along that centre line to the prolongation easterly of the southern side of Keenan Street, a point on a present southern boundary of the City of Armadale.

1.21) Thence generally westerly, generally north-westerly, again generally westerly, generally southerly, again generally westerly, and generally northerly along the common boundaries of the City of Armadale and the Shire of Serpentine-Jarrahdale to the south-western corner of Lot 5072, as shown on Deposited Plan 30019.

1.22) Thence easterly and northerly along the southern and eastern boundaries of that lot and onwards to the south-eastern corner of Lot 4788, as shown on Deposited Plan 30019.

1.23) Thence northerly along the eastern boundary of that lot and onwards to the southern side of Rowley Road.

1.24) Thence westerly along that side to the centre line of Tonkin Highway (undedicated).

1.25) Thence generally north-westerly, generally north-easterly and again generally north-westerly along that centre line to the centre line of Armadale Road.

1.26) Thence generally easterly along that centre line to the prolongation southerly of the centre line of Lake Road.

1.27) Thence northerly to and generally northerly and generally north-easterly along that centre line to the prolongation southerly of the centre line of Ranford Road.

1.28) Thence northerly to and generally northerly and generally north-westerly along that centre line to the centre line of Tonkin Highway (undedicated).

1.29) Thence north-easterly along that centre line to the starting point.

State Electoral District of  
**Balcatta**  
NORTH METROPOLITAN REGION

All that portion of land bounded by lines:

- 1.1) Commencing at the intersection of the centre line of Beach Road with the centre line of Mitchell Freeway (dedicated and undedicated) and extending generally south-easterly, generally south-westerly and again generally south-easterly along the centre line of Mitchell Freeway to the centre line of Scarborough Beach Road.
- 1.2) Thence generally easterly and generally south-easterly along that centre line to the prolongation westerly of the centre line of Green Street.
- 1.3) Thence easterly to and generally easterly and north-easterly along that centre line and onwards to the centre line of Wanneroo Road.
- 1.4) Thence generally north-westerly along that centre line to the prolongation north-easterly of the centre line of Blissett Way.
- 1.5) Thence south-westerly to and generally south-westerly and generally westerly along that centre line and onwards to the easternmost eastern boundary of Lot 8533 (Reserve 30500-Recreation), as shown on Plan 9268.
- 1.6) Thence south along that boundary to the northernmost northern boundary of Lot 801, as shown on Deposited Plan 64051.
- 1.7) Thence westerly along that boundary and south-westerly along the north-western boundary of that lot to the centre line of Lennox Place.
- 1.8) Thence westerly along that centre line and onwards to the centre line of Erindale Road.
- 1.9) Thence generally northerly, generally north-easterly and generally north-westerly along that centre line to the centre line of the eastern section of Beach Road.
- 1.10) Thence generally south-westerly and generally westerly along that centre line to the starting point.

State Electoral District of  
**Bassendean**  
EAST METROPOLITAN REGION

All that portion of land bounded by lines:

- 1.1) Commencing at the intersection of the prolongation north-westerly of the centre line of Tonkin Highway with the centre line of Reid Highway (dedicated and undedicated) and extending generally north-easterly, generally easterly and again generally north-easterly along the centre line of Reid Highway to the prolongation north-westerly of the centre line of the southern section of Lord Street (dedicated and undedicated).
- 1.2) Thence south-easterly to and south-easterly, generally southerly, generally south-easterly and generally south-westerly along that centre line to the prolongation westerly of the northern boundary of Lot 3003 (Reserve 47783-Use and Requirements of the Minister for Works) as shown on Deposited Plan 42646, a point on a present northern boundary of the Town of Bassendean.
- 1.3) Thence easterly, generally south-easterly and generally south-westerly along the common boundaries of the Town of Bassendean and the City of Swan and onwards to the centre line of the Swan River.
- 1.4) Thence generally south-westerly, generally south-easterly, again generally south-westerly, generally north-westerly and again generally south-westerly downwards along that centre line to the prolongation south-easterly of the north-eastern boundary of Lot 1026, as shown on Diagram 9013.
- 1.5) Thence north-westerly along that prolongation to its intersection with the right bank of the Swan River, the present southernmost south-eastern corner of the Town of Bassendean.
- 1.6) Thence north-westerly, generally north-easterly, generally north-westerly, again generally north-easterly, again generally north-westerly, again generally north-easterly again generally north-westerly and north-easterly along common boundaries of the Town of Bassendean and the City of Bayswater to the prolongation north-westerly of the centre line of Broadway, a present north-western corner of the Town of Bassendean.
- 1.7) Thence north-easterly and northerly along the centre line of Grey Street and onwards to the centre line of Walter Road East (dedicated and undedicated).
- 1.8) Thence generally westerly and generally south-westerly along that centre line to the prolongation north-easterly of the centre line of Broun Avenue (undedicated).
- 1.9) Thence generally south-westerly to and along that centre line to the centre line of the north-western section of Tonkin Highway (undedicated).
- 1.10) Thence generally north-westerly along that centre line to the prolongation easterly of the centre line of Walter Road West.
- 1.11) Thence westerly along that prolongation to the centre line of Tonkin Highway (undedicated and dedicated).
- 1.12) Thence generally north-westerly, generally north-easterly and again generally north-westerly along that centre line to the starting point.

State Electoral District of  
**Bateman**  
SOUTH METROPOLITAN REGION

All that portion of land bounded by lines:

- 1.1) Commencing at the intersection of the prolongation westerly of the southern boundary of Lot 72, as shown on Plan 12704, with the centre line Karel Avenue, a present south-western corner of the City of Canning and extending south-westerly along that centre line to the centre line of South Street (dedicated and undedicated).
- 1.2) Thence generally north-westerly and generally westerly along that centre line to the centre line of Kwinana Freeway (dedicated and undedicated).
- 1.3) Thence generally south-westerly along that centre line to the centre line of Farrington Road (dedicated and undedicated), a present north-eastern corner of the City of Cockburn.
- 1.4) Thence generally south-westerly, generally westerly, generally north-westerly and again generally south-westerly along that centre line and onwards to the centre line of North Lake Road (dedicated and undedicated).
- 1.5) Thence generally north-westerly, generally northerly, generally north-easterly and again generally northerly along that centre line to the centre line of Leach Highway.
- 1.6) Thence generally south-westerly along that centre line to the prolongation southerly of the centre line of Rome Road.
- 1.7) Thence northerly to and along that centre line to the centre line of Kitchener Road.
- 1.8) Thence easterly along that centre line to the centre line of Norma Road.
- 1.9) Thence southerly along that centre line to the centre line of Marmion Street.
- 1.10) Thence generally easterly, generally north-easterly and generally south-easterly along that centre line and onwards to the centre line of Riseley Street.
- 1.11) Thence north-easterly along that centre line to the prolongation westerly of the centre line of Davenport Road.
- 1.12) Thence easterly to and generally easterly, generally south-easterly and easterly along that centre line and onwards to the centre line of Rogerson Road.
- 1.13) Thence southerly along that centre line and onwards to the centre line of Canning Avenue.
- 1.14) Thence generally north-easterly, generally easterly and again generally north-easterly along that centre line and onwards to the centre line of the Canning River.
- 1.15) Thence generally south-easterly upwards along that centre line to the prolongation north-easterly of the centre line of Bull Creek.
- 1.16) Thence south-westerly to and generally south-westerly, generally south-easterly, again generally south-westerly and again generally south-easterly upwards along that centre line to the westernmost north-western corner of Lot 2145 (Reserve 29130 – Conservation “Yagan Park”), as shown on Deposited Plan 220483, a present north-western corner of the City of Canning.
- 1.17) Thence generally southerly, south-easterly, north-easterly, easterly and generally south-westerly along the common boundaries of the cities of Melville and Canning to the starting point.

State Electoral District of  
**Belmont**  
EAST METROPOLITAN REGION

All that portion of land bounded by lines:

1.1) Commencing at the intersection of the centre line of the Swan River with the prolongation westerly of the centre line of the Helena River and extending easterly to and generally easterly, generally south-easterly, generally north-easterly and generally northerly upwards along the centre line of the Helena River to the prolongation north-westerly of the northernmost north-eastern boundary of Lot 9002 as shown on Deposited Plan 56679.

1.2) Thence south-easterly to and along that boundary to the northernmost north-western corner of Lot 9007 as shown on Deposited Plan 67206.

1.3) Thence south-easterly along the north-eastern boundary of that lot to the north-western corner of the northern severance of Lot 77 as shown on Plan 7492 (sheet 1).

1.4) Thence south-easterly along the north-eastern boundary of that lot to the centre line of the Midland to Kwinana Railway.

1.5) Thence generally south-westerly, generally south-easterly and generally southerly along that centre line to the centre line of Kalamunda Road.

1.6) Thence south-easterly along that centre line to the prolongation north-easterly of the centre line of Abernethy Road (dedicated and undedicated).

1.7) Thence south-westerly to and generally south-westerly along that centre line to the prolongation north-easterly of the centre line of Dundas Road (adjacent to the north-western boundary of Lot 113, as shown on Deposited Plan 29302).

1.8) Thence south-westerly to and south-westerly, generally south-easterly and again generally south-westerly along the centre line of Dundas Road (dedicated and undedicated) to the centre line of Tonkin Highway (dedicated and undedicated).

1.9) Thence north-westerly along that centre line to the prolongation south-westerly of the easternmost south-eastern boundary of Lot 389, as shown on Plan 2284 (sheet 1), a point on a present south-eastern boundary of the City of Belmont.

1.10) Thence south-westerly, south-easterly, generally south-westerly and generally south-easterly along the common boundaries of the City of Belmont and the Shire of Kalamunda to the easternmost north-eastern corner of the City of Canning.

1.11) Thence generally south-westerly, generally south-easterly and again generally south-westerly along the common boundaries of the City of Canning and the Shire of Kalamunda to the northernmost north-eastern boundary of the City of Gosnells.

1.12) Thence north-westerly and south-westerly along the common boundaries of the Cities of Canning and Gosnells to the centre line of Welshpool Road East (dedicated and undedicated).

1.13) Thence generally north-westerly along that centre line to the centre line of Orrong Road (dedicated and undedicated).

1.14) Thence generally north-westerly along that centre line to the prolongation south-easterly of the centre line of William Street.

1.15) Thence north-westerly to and along that centre line and onwards to the centre line of Welshpool Road.

1.16) Thence generally north-westerly along that centre line to the centre line of the north-eastern section of Mills Street.

1.17) Thence north-easterly along that centre line and onwards to the centre line of Orrong Road.

1.18) Thence generally north-westerly along that centre line to the north-western side of the south-western section of Kew Street, a point on the present easternmost south-eastern boundary of the Town of Victoria Park.

1.19) Thence north-easterly along the common boundary of the City of Canning and the Town of Victoria Park to the westernmost south-western boundary of the City of Belmont.

1.20) Thence north-westerly along the common boundary of the City of Belmont and the Town of Victoria Park to the south-eastern corner of Lot 3, as shown on Deposited Plan 46306, the present westernmost north-western corner of the City of Belmont.

1.21) Thence north-easterly along the prolongation north-easterly of the south-eastern boundary of that lot to the centre line of the Swan River.

1.22) Thence generally south-easterly, generally north-easterly, generally north-westerly, again generally north-easterly, again generally south-easterly and again generally north-easterly upwards along that centre line to the starting point.

**Bunbury**  
SOUTH WEST REGION

All that portion of land bounded by lines:

1) Comprising the local government area of the City of Bunbury.

2.1) Comprising part of the local government area of the Shire of Harvey, commencing at the intersection of an east-west line passing through the northern extremity of Pelican Point with the centre line of Leschenault Estuary and extending generally north-easterly upwards along that centreline to the prolongation westerly of the centre line of Paris Road.

2.2) Thence easterly to and generally easterly, generally north-easterly, generally south-easterly and again generally north-easterly along that centre line to the centre line of the Brunswick River.

2.3) Thence generally south-easterly, generally southerly, generally south-westerly, again generally south-easterly and again generally southerly downwards along that centre line and onwards to the left bank of the Collie River, a point on a present northern boundary of the Shire of Dardanup.

2.4) Thence generally westerly, generally southerly, generally south-westerly, again generally westerly and generally north-westerly downwards along that bank to intersect with an east-west line passing through the northern extremity of Pelican Point.

2.5) Thence west along that line to the starting point.

3) Including the adjacent land between high and low water mark of the Indian Ocean.

State Electoral District of  
**Butler**  
NORTH METROPOLITAN REGION

All that portion of land bounded by lines:

1.1) Commencing at the intersection of the prolongation north-westerly of the south-western boundary of Lot 8, as shown on Plan 7782 with the centre line of Joondalup Drive, a point on a present south-western boundary of the City of Wanneroo and extending generally north-easterly along that centre line to the centre line of Wanneroo Road.

1.2) Thence generally north-westerly along that centre line to the prolongation south-westerly of the centre line of Flynn Drive.

1.3) Thence north-easterly to and generally north-easterly, generally north-westerly, again generally north-easterly, generally south-easterly, generally easterly and north-easterly along that centre line to the prolongation north-westerly of the centre line of the proposed extension of Pinjar Road (unconstructed and undedicated).

1.4) Thence south-easterly to and generally south-easterly, generally south-westerly, generally southerly and again generally south-easterly along that proposed centre line to the centre line of Pinjar Road.

1.5) Thence generally south-easterly and generally southerly along that centre line to the prolongation south-westerly of the centre line of Mornington Drive.

1.6) Thence north-easterly to and generally north-easterly along that centre line and onwards to the centre line of Greenvale Place.

1.7) Thence generally north-easterly along that centre line and onwards to the prolongation north-westerly of the centre line of Neaves Road.

1.8) Thence south-easterly to and generally south-easterly, generally north-easterly, again generally south-easterly, again generally north-easterly and generally easterly along that centre line to the prolongation south-westerly of the centre line of an unnamed road.

1.9) Thence north-easterly to and north-easterly and easterly along the centre line of the unnamed road passing along the north-western boundary of Lot 33, the north-western and northern boundaries of Lot 35 and the northern boundaries of Lots 36 to 39 inclusive, as shown on Plan 16878, and onwards to the centre line of Neaves Road.

1.10) Thence north-easterly along that centre line to the prolongation northerly of the eastern boundary of Lot 13, as shown Diagram 76184, a point on the present easternmost eastern boundary of the City of Wanneroo.

1.11) Thence northerly along the common boundary of the Cities of Wanneroo and Swan to the southernmost southern boundary of the Shire of Chittering.

1.12) Thence westerly, northerly, again westerly and again northerly along the common boundaries of the City of Wanneroo and the Shire of Chittering to a southern boundary of the Shire of Gingin.

1.13) Thence westerly, generally north-westerly and again westerly along the common boundaries of the City of Wanneroo and the Shire of Gingin to the low water mark of the Indian Ocean, the present westernmost north-western corner of the City of Wanneroo.

1.14) Thence generally south-easterly along that mark to the prolongation south-westerly of the centre line of Quinns Road.

1.15) Thence north-easterly to and generally north-easterly along that centre line and onwards to the centre line of Marmion Avenue.

1.16) Thence generally south-easterly, generally southerly and again generally south-easterly along that centre line to the prolongation westerly of the northern boundary of Lot 91 (Reserve 47117 – Public Recreation), as shown on Plan 23628, a point on a present southern boundary of the City of Wanneroo.

1.17) Thence easterly, generally south-easterly, generally north-easterly again generally south-easterly, again generally north-easterly and south-easterly along the common boundaries of the Cities of Wanneroo and Joondalup to the starting point.

2) Including adjacent islands.

State Electoral District of  
**Cannington**  
SOUTH METROPOLITAN REGION

All that portion of land bounded by lines:

1.1) Commencing at the intersection of the centre line of the Canning River with the prolongation south-westerly of the north-western boundary of Lot 4190 (Reserve 36621-Parks and Recreation), as shown on Deposited Plan 219831 and extending north-easterly along that prolongation to the north-western corner of that lot, a present north-western corner of the City of Canning.

1.2) Thence north-easterly and north-westerly along the common boundaries of the Cities of Canning and South Perth to the centre line of Manning Road.

1.3) Thence generally north-easterly and generally south-easterly along that centre line to the prolongation south-westerly of the centre line of Burton Street (dedicated and undedicated).

1.4) Thence north-easterly to and along that centre line and onwards to the centre line of Albany Highway.

1.5) Thence generally north-westerly along that centre line to the prolongation south-westerly of the centre line of the south-western section of Mills Street.

1.6) Thence north-easterly to and generally north-easterly along that centre line and onwards to and north-easterly along the centre line of the north-eastern section of Mills Street to the centre line of Welshpool Road.

1.7) Thence generally south-easterly along that centre line and onwards to the centre line of William Street.

1.8) Thence south-easterly along that centre line and onwards to the centre line of Orrong Road (dedicated and undedicated).

1.9) Thence generally south-easterly along that centre line to the centre line of Welshpool Road East (dedicated and undedicated).

1.10) Thence generally south-easterly along that centre line to the south-eastern boundary of Lot 15, as shown on Deposited Plan 27945, a point on a present south-eastern boundary of the City of Canning.

1.11) Thence north-easterly and south-easterly along the common boundaries of the Cities of Canning and Gosnells to the centre line of the Midland to Kwinana Railway, a present south-western corner of the Shire of Kalamunda.

1.12) Thence generally south-westerly, generally southerly and again generally south-westerly along the centre line of the Midland to Kwinana Railway to the centre line of Nicholson Road.

1.13) Thence north-westerly along that centre line to the prolongation north-easterly of the north-western boundary of Lot 300 (Reserve 48703-Railway), as shown on Deposited Plan 50182, a point on a present north-western boundary of the City of Gosnells.

1.14) Thence north-easterly, north-westerly and again north-easterly along the common boundaries of the Cities of Gosnells and Canning to the prolongation south-easterly of the centre line of High Road.

1.15) Thence north-westerly to and generally north-westerly along that centre line to the prolongation south-westerly of the westernmost north-western boundary of Lot 2, as shown on Diagram 53768.

1.16) Thence north-easterly to and north-easterly and north-westerly along north-western and south-western boundaries of that lot to its northernmost north-western corner.

1.17) Thence north-westerly to the southernmost south-western corner of Lot 1201, as shown on Diagram 53049.

1.18) Thence northerly, generally north-westerly, north-easterly and easterly along boundaries of that lot to the prolongation southerly of the western boundary of Lot 33, as shown on Plan 7795.

1.19) Thence northerly to and northerly and north-westerly along the western and south-western boundaries of that lot and onwards to the centre line of the Canning River.

1.20) Thence generally south-westerly, generally north-westerly, generally northerly and again generally north-westerly downwards along that centre line to the starting point.

NORTH METROPOLITAN REGION

All that portion of land bounded by lines:

#### **MUNICIPALITY INDEX**

This index provides a ready reference covering all current and past municipalities for the State. The Municipality Index lists all occurrences of municipalities with the date of creation, date of last amendment and date of last redescription if available. They are listed by name and in chronological order within municipality name.

Thus, normally a Road District would precede a Town and subsequently a Shire or City. The accompanying diagram indicates how this Municipality Index can act as an aid in locating which municipality may contain the detail required. The separate Municipality Boundary Amendments Register may then be referred for the actual *Government Gazette* issue date and page reference.

In some instances, a municipality has been dissolved and at a later date recreated. When this has occurred, a numerical suffix has been added to the name to differentiate between the two "lifetimes" of the municipality. In these cases, the second use of the name may be in a different location to the first. Examples of this may be found with Ashburton, Belmont, Broome and others.

The Municipality Boundary Amendments Register is published in conjunction with divisions of the State. The fourth publication of the Municipality Boundary Amendments Register was published in special *Government Gazette* No. 191 on 10 October 2011 and has been timed to coincide with the publication of this division of the State. It includes details of local government boundary changes up to and including 31 July 2011.

The Municipality Boundary Amendments Register is maintained and updated by the Department of Local Government.

The technical description for the State Electoral District of Wanneroo contains references to City and Shire boundaries.
