# Submission of the Australian Labor Party (Western Australian Branch) to the Electoral Distribution Commissioners for the 2003 Distribution for the State of Western Australia

This is the submission of the Australian Labor Party (Western Australian Branch) ("ALP") to the Electoral Distribution Commissioners for the 2003 Distribution for the State of Western Australia. The submission is made by the State Secretary of the Party on behalf of the Party.

#### **Background**

In forming these suggestions to the Commissioners, the ALP has been mindful of the obligations on the Commissioners contained in the Electoral Distribution Act 1947 ("the Act").

Clearly, these obligations do not go to any attempt to deal with the electorates' political views. Submissions by political parties, whether from the ALP or any other party, should not attempt to re-fight the last State election. That was a matter for the people of this State, and is not relevant to this process.

In the process of the Commissioners properly addressing their obligations, they should carefully examine wild submissions from political parties that attempt to significantly change the balance of districts for their *opponents*. That is not the purpose of this process. Rightly, the process should focus only the obligations provided by the Act.

#### **ALP Submission**

In forming the ALP submission, we have had regard to the Act. Our submissions are designed to provide Districts and Regions that conform to the obligations placed on the Commissioners

All 57 of our proposed districts have been drawn to:

- establish community of interest;
- consider issues of communications and distance from the capital;
- take into account physical features;
- have proper regard for the existing boundaries of regions and districts;
- consider existing local government boundaries; and
- take account of trends of demographic changes.

We have also had regard to the electoral enrolments, including projections, as provided by the West Australian Electoral Commission. All proposed districts fall within the range of plus or minus 15% from the allowable quota of voters for both metropolitan and non-metropolitan districts.

All districts should remain within the allowable variation of plus or minus 15% from the implied quota for projected enrolments.

Further, our proposed boundaries for Regions meet the criteria in Section 9 of the Act.

#### **Legislative Assembly Districts**

On the attached pages of this submission are the descriptions of the 57 proposed seats, plus indicative maps for each proposed boundary. These suggestions conform with the obligations in the Act.

If the ALP submission requires a seat to be created in a new context, we have made a suggestion for a name for that district.

#### **Legislative Council Regions**

Further, the ALP also proposes that the six Legislative Council Regions should constitute the following list of Legislative Assembly districts:

Metropolitan Area - 34 seats (s. 6(1)(a))

East Metropolitan Region

Armadale, Ballajura, Bassendean, Belmont, Darling Range, Midland, Roleystone, Southern River, Swan Hills and Thornlie (10 seats)

North Metropolitan Region

Carine, Churchlands, Cottesloe, Hillarys, Innaloo, Joondalup, Kingsley, Marangaroo, Maylands, Nedlands, Nollamara, Perth, Wanneroo and Yokine (14 seats)

South Metropolitan Region

Alfred Cove, Cockburn, Fremantle, Murdoch, Peel, Riverton, Rockingham, South Perth, Victoria Park and Willagee (10 seats)

Remainder of the State - 23 seats (s. 6(1)(b))

Agricultural Region

Avon, Geraldton, Greenough, Merredin, Moore, Roe and Wagin (7 seats)

Mining and Pastoral Region

Eyre, Kalgoorlie, Kimberley, Ningaloo and Pilbara (5 seats)

South West Region

Albany, Bunbury, Bussell, Dawesville, Frankland, Holman, Mandurah, Mitchell, Murray, Stirling and Vasse (11 seats)

These proposals conform to the obligations of the Commissioners in the Act.

#### Conclusion

The ALP submission is made with proper regard for the obligations placed on the Commissioners by the Act. We believe that the Commissioners should carefully consider our submissions in their deliberations. We believe that they form a proper basis for the distribution of Districts and Regions in the State.

#### **Attachment Describing the Boundaries for 57 Proposed Districts**

**District** ALBANY

**Region** South West

#### **Proposed Boundary**

The proposed boundary for the District of Albany is bounded by the shore line of the Princess Royal Harbour in the south and Oyster Harbour on the western boundary. Extending from western edge of LGA boundary of Albany to outlet of Yakamia Creek in Oyster Harbour. The western boundary extending north west along the drain adjacent to Robertson Rd to the locality boundary of Mount Elphinstone, north along the locality boundary to north of the locality then extending west into Cumming Rd, north along Balston Rd, Clydesdale Rd to Dome Rd to Albany Hwy. North along Albany Hwy to Rufus St, north along Havoc Rd to Henry Rd to Chester Pass Rd. South along Chester Pass Rd to Hudson St then following the northern boundary of the locality of Yakamia to the Yakamia Creek which forms the locality boundary of Collingwood Heights.

**District** ALFRED COVE

**Region** South Metropolitan

#### **Proposed Boundary**

The proposed boundary for the District of Alfred Cove — is bounded on the north and east by the Swan River. Following the current District boundary west along Canning Hwy, Rogerson Rd, Davenport Rd, Risley St, Marmion St to Norma Rd North along Norma Rd to Kitchener Rd, west along Kitchener Rd to North Lake Rd, south along north Lake Rd to Marmion St, west along Marmion St to Redwood Cr, north along Redwood Cr to Coleman Cr. West along Coleman Cr to Stock Rd, south along Stock Rd to Marmion St, west along Marmion St to Petra St, north along Petra St, Zenobia St, east along Zenobia St to Mckimmie Rd, north along Mckimmie Rd, Point Walter Rd to Beach St along Beach St to the Swan River.

District ARMADALE

**Region** East Metropolitan

#### **Proposed Boundary**

The proposed boundary for the District of Armadale — the northern boundary bounded by the current District boundary along Lake Rd , Canning River, the LGA boundary Armadale along Canning following the current District boundary from Buchanan Rd Mills Rd along Canning Mills Rd to Grade St. South along Roberts Rd to Bernard St, east along Bernard St to the Canning River, along the Canning River passing under the Buckingham Bridge on the Brookton Hwy to Mount St, south along the current District boundary on Mount St, Scott Rd, Lang St the suburb boundary of Kelmscott , Patterson Rd, Blackwood Dr, Canns Rd, Carradine Rd, Albany Hwy, to the junction of Albany Hwy and Bedfordale Hill Rd. South west along the suburb boundary of Armadale to the rail line. South along the rail line to the Armadale LGA boundary. Following the LGA boundary to and along Rowley Rd to Albert Rd. North along Albert Rd for about 950 meters then north west connecting with Forrest Rd to Twelfth Rd, north along Twelfth Rd to Armadale Rd and along Armadale Rd to the current District boundary along Lake Rd to the Canning River.

District BALLAJURRA

**Region** East Metropolitan

#### **Proposed boundary**

The proposed boundary for the District of Ballajura northern border starts at the junction of Sydney St and Gnangara Rd west along Gnangara Rd from that point to the junction of North Beechboro Rd. South along North Beechboro Rd to Reid Hwy. South west along Reid Hwy to Tonkin Hwy. South along Tonkin Hwy to a point adjacent to Walter Rd West. Extending west along Walter Rd West to the intersection of Wellington St. North West along Wellington St along the LGA boundary to the intersection of Gordon Rd West then west along Gordon Rd west to Alexander Drive. North along Alexander Drive following the LGA boundary of Wanneroo and Swan to Gnangara Rd.

**District** BASS ENDEAN

**Region** East Metropolitan

#### **Proposed Boundary**

The proposed boundary for the District of Bassendean — from the intersection of Tonkin Hwy and Reid Hwy north east along Reid Hwy to Altone Rd. South along Altone Rd to Benara Rd. East along Banara Rd to Lord St. South along Lord St to Morley Drive East. East along the LGA boundary of Bassendean following it south west to the banks of the Swan River. Following the banks of the Swan River in a westerly direction to Tonkin Hwy then north west along the Tonkin Hwy to Railway Parade. North east along Railway Parade to Vincent St and following the LGA boundary of Bassendean/Bayswater along Clune St, Duffy St, Jackson St to Collier Rd. West along Collier Rd to Crimea St. North along Crimea St to Walter Rd. East along Walter Rd West to Tonkin Hwy. North along Tonkin Hwy to Reid Hwy.

**District BELMONT** 

**Region** East Metropolitan

#### **Proposed Boundary**

The proposed boundary for the District of Belmont — is bounded by the Swan River on the north from the Graham Farmer Fwy to suburb boundary of Redcliffe and South Guildford. Along the current boundary to Great Eastern Hwy Bypass, Kalamunda Rd, along the alignment of Abernethy and Dundas Rd, Maida Vale Rd to Roe Hwy. South along Roe Hwy to Bershire Rd south along Birshire Rd to Hawtin Rd, south along Hawtin Rd, Anderson Rd to Holmes Rd, North East along Holmes Rd to Wandoo Rd. South East along Wandoo Rd to Lewis Rd. South west along Lewis Rd to Hartfield Rd. Following a current District boundary along Hartfield Rd, Hale Rd. Tonkin Hwy to Roe Hwy. South west along Roe Hwy to Welshpool Rd west along Welshpool Rd to the current District boundary along Kewdale Rd, Orrong Rd and Graham Farmer Fwy to the Swan River.

**District BUNBURY** 

**Region** South West

#### **Proposed Boundary**

The proposed boundary for the District of Bunbury — western boundary is the coast line. The southern boundary is the LGA boundary extending from the coast line to the Boy anup Rd. North along Boy anup Rd to the intersection of Robertson Rd. Continuing west connecting with Milligan St, Ausden St, Winton St, Nuysia Ave and north along Blair St to Sandridge Rd. East along Sandridge Rd to the Australind Bypass to the Bunbury LGA Boundary. Following the boundary to the coast line.

District BUSSELL

**Region** South West

#### **Proposed Boundary**

The proposed boundary for the District of Bussell — western boundary is the coast line from Fort St in the LGA of Busselton along the coast line to where the LGA boundary of Capel meets the LGA boundary of Bunbury. Following the LGA boundary of Capel and Busselton to where the LGA boundary of Busselton meets the Vasse Hwy. North along the Vasse Hwy to the southern boundary of the Sir Stewart Bovell Sporting Complex. From this point along the perimeter of the complex in a south west direction meeting the Chapman Hill Rd, then west meeting the Queen Elizabeth Ave about 350 meters south of Walsh Rd. West along Walsh Rd, north along Fairway Drive to the New River, east along the waterway to a point adjacent to Gross Rd, north along Gross Rd to the Bussell Hwy, west along the Hwy to Forth St.

**District** CARINE

**Region** North Metropolitan

#### Proposed boundary

The proposed boundary for the District of Carine is bordered on the west by coast. From the coast the north boundary travels along The Plaza in the Suburb of Sorrento in an easterly direction to the intersection of Padbury Circle. In a northerly direction along Padbury circle to the intersection of Hocking Parade then along Hocking Parade to the intersection of St Helier Drive. Easterly along St Helier Drive to the intersection of Marmion Avenue. In a northerly direction along Marmion Avenue to the intersection of the Mitchell Freeway. Southerly along the Mitchell Freeway to the intersection of Erindale Road. Westerly along Erindale Road to a point adjacent to Lake Karrinyup Golf Course and following in part the suburb boundaries of Gwelup and Karrinyup in a westerly direction, then along Pascoe St in a westerly direction to the intersection of Milverton Avenue. In a southerly direction along Milverton Avenue to Karrinyup Road. West along Karrinyup Road to the intersection of West Coast Drive. In a northerly direction along West Coast Drive to a point adjacent to Kathleen St then west to the coast line.

**District** CHURCHLANDS

**Region** North Metropolitan

#### **Proposed boundary**

The proposed boundary for the District of Churchlands is bordered on the west by coast. From a point from the coast line to Brighton Rd in Scarborough and along Brighton Rd in an easterly direction to the intersection of Deanmore. North along Deanmore to Scarborough Beach Rd then in an easterly along Scarborough Beach Rd to Stephenson Avenue then in a southerly direction to Jon Sanders Drive then along Jon Sanders Drive to the intersection of Harbourne St. South along Harborne St to Dodd St, then east along Dodd St to Gregory St then south along Gregory St to Grantham, west along Grantham St to Selby St, south along Selby St to Cambridge St, west along Cambridge St, Oceanic Drive to the coast line.

District COCKBURN

**Region** South Metropolitan

#### **Proposed Boundary**

The proposed boundary for the District of Cockburn — part of the the western boundary of Cockburn is the coast line. From a point on the coast line adjacent to Nyverbup Circle along Nyverbup to Cockburn Rd, north along Cockburn Rd to Fairbairn Rd, west along Fairbairn Rd to Luscombe Way, north along Luscombe Way to Castellon Cr, east along Castellon Cr to Longreach Pde, north along Longreach Pde to Amity Bvd, north east along Amity Blvd to Hamilton Rd south along Hamilton Rd to Troode St, west along Troode St to Rockingham Rd, north along Rockingham Rd, Phoenix Rd, east along phoenix Rd to Stock Rd, north along Stock Rd to Forrest Rd, East along Forrest Rd to Carrington St then along the current District boundary along Forrest Rd, Gwilliam Dr, Progress Dr, Farrington St to the LGA boundary of Melville and Cockburn. Generally east along the LGA boundary to the Kwinana Fwy, south along the Fwy and the current District boundary to Thomas Rd, west along Thomas Rd to a point adjacent to Nottingham Wy, south along Nottingham Wy, along Sulphur Rd, Summerton Rd, Stanford Wy, Gentle Rd, west along the LGA boundary - Wellard Rd, Officer Rd, Rockingham Rd to the shore line.

District COTTESLOE

**Region** North Metropolitan

#### Proposed boundary

The proposed boundary for the District of Cottesloe is bordered on the west by coast. From a point from the coast line easterly along Oceanic Drive and Cambridge St to Selby St. South along Selby St to Lonnie St, east along Lonnie St to the Perth to Fremantle rail line, south west along the rail line to Loch St, then south along Loch St to Stirling Hwy, then following the suburb boundary of Claremont in a southerly direction along Bay Rd to the intersection of Belvista, west along Belvista to Stone Rd, south along Stone Rd to Watkins Rd, west along Watkins Rd to the shore line of the Swan River. The boundary then following the shore line of the river in a westerly direction to the coast.

**District DARLING RANGE** 

**Region** East Metropolitan

#### **Proposed Boundary**

The proposed boundary for the District of Darling Range – from intersection of the LGA boundaries of Swan, Toodyay and Mundaring the boundary follows the western part of the LGA of Mundaring to the suburb boundary of Stoneville, joins Mt Helena on Cameron Rd. South along the suburb boundaries to a point adjacent to the Mundaring light industrial area. The boundary extending along the perimeter of the Industrial Area to Darken St, then north to Jacoby St. Westerly along Jacoby St to Maddock St. South along Maddock St to Phillips St. North west along Phillips St to Coolgardie St. South along Coolgardie St to Reddy Ave. West along Reddy Ave to Martin Rd. Then following the perimeter of the State Forest firstly in a northerly direction and then following the perimeter joining Coppin Rd and the suburb boundary of Mahogany Creek to O'Connor Rd. North along O'Connor Rd for about 280 meters. Then west along the boundary park land to Mool Rd. South along Mool Rd to the extension of Glenburn Rd. West along Glenburn Rd/Duffield Rd to Ryecroft Rd. North along the suburb boundary of Darlington to Great Eastern Hwy. West along the Great Eastern Hwy to point adjacent to Convict Creek then southerly along Convict Creek to the Creek intersect the suburb boundary of Greenmount. North West along the suburb boundary to Scott St then south along Scott St the Helena River. Then following the length of Helena River in a westerly direction to the Roe Hwy. South along the Roe Hwy to Maida Vale Rd. South along Roe Hwy to Bershire Rd, south along Birshire Rd to Hawtin Rd, south along Hawtin Rd, Anderson Rd to Holmes Rd, North East along Holmes Rd to Wandoo Rd. South East along Wandoo Rd to Lewis Rd. South west along Lewis Rd to Hartfield Rd. Following a current District boundary along Hartfield Rd, Hale Rd, and Tonkin Hwy to Roe Hwy. South west along Roe Hwy to Welshpool Rd. East along Welshpool Rd to the LGA boundary of Kalamunda and Gosnells. Following the LGA boundaries of Kalamunda and Gosnells. East along the Kalamunda and Armadale LGA boundaries then north along the Kalamunda and York LGA boundary then the Mundaring and York boundary to where the Swan, Toodyay and Mundaring LGA boundaries meet forming the northern boundary of the District.

**District DAWES VILLE** 

**Region** South West

#### **Proposed Boundary**

The proposed boundary for the District of Dawesville — western boundary is the coast line. The southern boundary is the LGA boundary of Mandurah. The eastern boundary is the Peel Inlet and the Mandurah Estuary.

**District** EYRE

**Region** Mining & Pastoral

#### **Proposed Boundary**

The proposed boundary for the District of Eyre takes in the Shires of Upper Gascoyne, Murchison, Meekatharra, Cue, Yalgoo, Mount Magnet, Standstone, Wiluna, Ngaanyatjarraku, Leonora, Lavarton, Menzies, Yilgarn, Coolgardie, Dundas and part of the City of Kalgoorlie/Boulder. The part excluded are contained within the District of Kalgoorlie which follows the current District boundary on the west, north and major portion on the East. Following the current boundary along Gatacre St to Bracklemann Drive, south along Bracklemann Drive to Cavalier Crescent, east along Cavalier Crescent, Parry Way to Keegan St, north along Keegan St to Forest St, east along Forest St to the Goldfield Hwy. North along the Goldfields Hwy joining with the current boundary.

**District** FREMANTLE

**Region** South Metropolitan

#### **Proposed Boundary**

The proposed boundary for the District of Fremantle — is bounded on the west by the coast, and on the north by the Swan River. The boundary to the east runs from the Swan River along Beach St, south along Point Walter Rd to Zenobia St, west along Zenobia St to Petra St and the LGA boundary, south along Petra St along the LGA boundary to Marmion St east along Marmion St to Carrington St, south along Carrington St to Forrest Rd. West along Forrest Rd To Rockingham Rd, south along Rockingham Rd to Troode St in the suburb of Spearwood. West along Troode St Hamilton Rd, north along Hamilton Rd to Amity Bvd, west along Amity Bvd to Longreach Pde, south along Longreach Pde to Castellon Cr. West along Castellon Cr to Luscome Way, south along Luscome Way to Fairbairn Rd, west along Fairbairn Rd to Cockburn Rd, south along Cockburn Rd to Nyyerbup Circle, west along Nyyerbup Circle to the coast.

**District GERALDTON** 

**Region** Agriculture

#### **Proposed Boundary**

The proposed boundary for the District of Geraldton takes in the whole LGA of Geraldton including an area on the northern boundary of the LGA bounded by Stell St, Adelaide St, along Chapman Valley Rd for about 2.3km to a point north East of Kalee Close then south for about 200 meters then south west to the LGA boundary with Kalee Close, Jabiru way, Mugana Crescent west of the boundary.

**District** GREENOUGH

Region Agriculture

#### **Proposed Boundary**

The proposed boundary for the District of Greenough includes the LGA's of Northampton, Chapman Valley, Mullewa, Erwin, Mingenew, Morowa and part of Greenough excluding and area north of the LGA of Geraldton bounded by Stell St, Adelaide St, along Chapman Valley Rd for about 2.3km to a point north East of Kalee Close then south for about 200 meters then south west to the LGA boundary with Kalee Close, Jabiru way, Mugana Crescent west of the boundary.

District HILLARYS

**Region** North Metropolitan

Proposed boundary

The proposed boundary for the District of Hillarys – from the coastline along the south perimeter of the Ocean Reef Harbour car park to Hodges Drive. Easterly along Hodges Drive to the intersection of Marmion Avenue. Then southerly along Marmion Ave to the intersection of Craigie Drive. Then in an Easterly direction along Craigie Drive to the intersection of Coyles Road following the suburb boundary of Craigie to the Mitchell Freeway. South along the Mitchell Freeway to the intersection of Hepburn Avenue. Westerly along Hepburn Avenue to the intersection of Marmion Avenue. Then south along Marmion Avenue to the intersection of Seacrest drive. Westerly along Seacrest Drive to the intersection of St Helier Drive to the intersection of Hocking Parade. Southerly along Hocking Parade to Padbury Circle. Down the westerly sector of Padbury Circle to the intersection of The Plaza then westerly to the coast.

District Holman

**Region** South West

#### **Proposed Boundary**

The proposed boundary for the District of Holman – includes the LGA of Collie and Dardanup plus part of the LGA of Bunbury from the south boundary of the LGA of Bunbury along the Boyanup Rd to the intersection of Robertson Rd. Continuing west connecting with Milligan St, Ausden St, Winton St, Nuysia Ave and north along Blair St to Sandridge Rd. East along Sandridge Rd to the Australind Bypass to where the Bunbury and Dardanup LGA boundaries meet the Harvey LGA boundary.

District INNALOO

**Region** North Metropolitan

#### Proposed boundary

The proposed boundary for the District of Innaloo is bordered on the west by coast. From a point from the coast to the junction of West Coast Drive and Kathleen St in the suburb of Trigg. South to Karrinyup Rd along West Coast Drive. East along Karrinyup Road to the intersection of Milverton Avenue. In a northerly direction along Milverton Ave to the intersection of Pascoe Street. In a easterly direction along Pascoe Street continuing in a easterly direction along the suburb boundary, then slightly north connecting to Erindale Road and continuing along Erindale Road to a point adjacent to Delawney St. East on Delawney St to a point north of Cedric St Balcatta. South on Cedric Street to the intersection of Dacre St. West along Dacre St to Felton St, then south along Felton St to the intersection of Attra St, then east to Mafton Rd. North along Mafton St to the intersection of Paskin St, east along Paskin St to the intersection of Jones St, then north along Jones St to the Intersection of Rickman St. East along Rickman St to the intersection of Main St. In a north east direction along Main St to Wanneroo Rd. Southerly along Wanneroo Rd to the intersection of Morley Drive. West along Morley drive to the intersection of Main St. South along Main St to the intersection of Hutton St. South west along Hutton St to the Mitchell Freeway. South along the Mitchell Freeway to Powis St. West along Powis St, joining Jon Sanders in a northerly direction to the junction Stephenson Ave. North along Stephnson Ave to Scarborough Beach Rd. Westerly along Scarborough Beach Rd to the intersection of Deanmore Rd. South along Deanmore Rd to Brighton Rd. West along Brighton Rd to the coastline.

**District** JOONDALUP

**Region** North Metropolitan

#### Proposed boundary

The proposed boundary of the District of Joondalup is bordered on the west by the coast. From the coast the northerly boundary follows the LGA boundary of Joondalup in an easterly direction to Wanneroo Road, then in a southerly direction along the Joondalup LGA border to the intersection of Burns Beach Road, then in a westerly direction along Burns Beach Road and the LGA border to a point on Joondalup Drive where the LGA border of Joondalup heads in a southerly direction through Lake Joondalup to point on the northern tip of Lake Island. The proposed boundary then travels in a westerly direction generally following the suburb boundary of Joondalup to the Lake Side Drive, then in a southerly direction generally along the suburb boundary of Joondalup to the intersection of Joondalup Drive. Then in a southerly direction to the intersection of Eddystone Avenue. Then in a westerly direction along Eddy stone Avenue to the Mitchell Freeway then in a southerly direction to the intersection of the Mitchell Freeway and Ocean reef Road. Then following the southern suburb boundary of Beldon in a westerly direction along Coyle Road and Craigie Drive to the intersection of Marmion Ave. In a northerly direction along Marmion Drive to the intersection of Hodges Drive. Along Hodges Drive in a westerly direction to the coast along the southern boundary of the Ocean Reef Harbour car park.

**District KALGOORLIE** 

**Region** Mining & Pastoral

#### **Proposed Boundary**

Proposed boundary for the District of Kalgoorlie follows the current District boundary on the west, north and major portion on the East. Following the current boundary along Gatacre St to Bracklemann Drive, south along Bracklemann Drive to Cavalier Crescent, east along Cavalier Crescent, Parry Way to Keegan St, north along Keegan St to Forest St, east along Forest St to the Goldfield Hwy. North along the Goldfields Hwy joining with the current boundary.

**District KIMBERLEY** 

**Region** Mining & Pastoral

#### **Proposed Boundary**

The proposed boundary for the District of Kimberley includes the LGA's of Wyndham-East Kimberley, Derby-West Kimberley and Broome.

District KINGS LEY
