Dear Electoral Distribution Commissioner

I submit that the district of Dawesville should have its name changed to South Mandurah.

The name change will decrease the unacceptably high level of confusion within the community.

Currently, many constituents within the district of Dawesville identify as part of the broader Mandurah community, particularly where they reside north of the Port Bouvard Bridge and south of the Estuary Bridge. This creates confusion and leads many constituents assuming they are in the district of Mandurah, as evidenced by the enormous correspondence the Member for Mandurah receives from Dawesville constituents assuming he is their local member.

The name South Mandurah would accurately reflect the geography and identity of the community encompassed in the current district of Dawesville and reduce confusion.

This proposal is also supported by the current Member for Mandurah.
