Re: Electoral Boundary Changes

It is with great concern and alarm that I view the proposed electoral boundary changes. It was only two years ago that changes were made and since that time there has been a Covid pandemic and many population changes due to city folk moving to (safer) country areas and many working from home in those areas since the pandemic changed workplace norms.

There is not a country town that has any 'freeboard' with regard to accommodation of any sort – rental properties, houses for sale, hotel accommodation, etc. This must indicate that the rural areas as fully occupied and that there is an urgent need for government oversight in regard to Health, Education, Town Planning, Law and Order, people management, water supplies and so on.
