# PROPOSAL: WA ELECTORAL PROPOSAL BY LUKE DIXON



Please see below my proposals for the WA State redistribution for use at the 2025 WA State Election. I have endeavoured to create as many 'equitable' seats as possible, with attempts to be made for seats to be as close to 'even' as possible, when taking into account the LDA.

I have endeavoured to have justifications and descriptions of boundary changes for each electorate, however if this is not complete then the SA1 numbers listed are to take precedent.

The following is a breakdown of the code used for this proposal.

CODE (EXAMPLE)

**WEST SWAN** +6.5

(Name of current or proposed electorate) (The estimated number in thousands that the electorate is over or under 'quota' as of the 2025 WA sate election.)

RATIONALE: (A brief explanation of why electorate changes have been proposed.) With this electorate being 6500 voters over quota and gaining 5500 voters and 4000 voters from Lansdale and Midland electorates, there will be a redistribution of 16000 voters to the new electorate of Ellenbrook.

BC: (Specific detail of proposed boundary changes to compliment SA1 numbers.)

At the Alexander Dr boundary, the electorate will branch west, the boundary proceeding down the centre of Marangaroo Dr. The boundary will then move north through Mirrabooka Ave, before moving east down Hepburn Ave. The electoral boundary will then continue north along Alexander Dr.

(16 to Ellenbrook, 5.5 from Lansdale, 3 from Midland, 1 from Bassendean)- The target number in thousands that is aimed to be moved into or out of specific electorates.)

#### PROPOSED 2023 WA STATE ELECTION BOUNDARIES

#### ALBANY: -3

LOGISTICS: An estimated short fall of 3000 voters would be addressed in this redistribution. The inclusion of the nearby country town of Murray Bridge is the best application from the Warren-Blackwood electorate is proposed.

BC: The Northern Boundary for the Albany electorate will start in the same position to the east before moving along the northern edge of Bluff Knoll and the Stirling Range national park. The boundary continues south down the western boundary of the Stirling Range national park. The boundary then moves west along the current boundary between Warren-Blackwood and Roe before moving south down the centre of the Albany Hwy. The boundary moves west down the centre of Muir Hwy before moving south down Hay River until meeting the ocean.

# **ARMADALE**: +3.5

RATIONALE: An estimated excess of 3500 voters would be addressed with this change. The railway acts as a logical boundary divide.

BD: The Armadale Train line now serves as the Eastern Boundary for the Armadale electorate. The eastern boundary moves in a Northerly direction along the Armadale Train line from Eleventh Rd, before moving west along the shared path linking Verna St. The boundary moves along Verna St, Passmore St, Phoebe St and in an easterly direction along Matison St through to Ranford Rd where the boundary moves south along the current boundary.

#### BALCATTA: -

RATIONALE: As the electorate is close to the expected quota, there is no need for changes at this time.

# **BALDIVIS**: +6.5

(6.5 to Kwinana)

RATIONALE: With an estimated 6500 voter over allotment, the redistribution of the Kwinana area to the Kwinana electorate is a logical decision. While an estimated amount of over 7000 is to be redistributed, this ensures the Kwinana area becomes in the one electorate.

BD: The changes will occur along the northern boundary. The boundary will now continue along the Willard railway, on to the Leda railway before joining the current boundary at the Mandurah line.

# **BASSENDEAN**: -

RATIONALE: While the electorate is on quota, minor changes are proposed to deal with proposed changes in other electorates.

BC: The South-West boundary now moves south down the Tonkin Hwy before moving east down the centre of Blackboy Way and the SA1 boundary through to Beechboro Rd N.

The Northern boundary now moves north along Bennett Brook from its current boundary near Lord St and Morley Dve through to Marshall Rd, where the boundary shifts to the west.

# **BOORAGOON** (BATEMAN)

LOGISTICS: Despite being on quota, there will be significant changes to accommodate for an over allotment in the western suburbs of Perth and changes to eastern suburbs due to the new seat of Ellenbrook. The removal of the Bateman suburb from the electorate has lead to the proposed name change to Booragoon.

BC: The southern boundary will now continue west along South St until Stock Rd. The boundary will then move north down the centre of Stock Rd before moving east down the centre of Leach Hwy. The boundary then move in a northern direction down North Lake Rd and SA1 boundary lines through to the Swan River.

The western boundary will now branch out from the Swan River at Queens Rd, travelling through the centre of this and Glencoe Rd before moving south down the centre of Risely St. The boundary moves east down the centre of Leach Hwy, before moving south down the centre of Murdoch Drv, before reaching South St, where the boundary continues down to the west.

RATIONALE: Due to the electorate being an estimated 2500 votes under quota, it is proposed that this will be redistributed from the over quota Fremantle electorate.

BC: The boundary will now move south down Stock Rd from Leach Hwy, moving west down the centre of South St. The boundary then follows the SA1 boundary north through the centres of Wiluna Ave, Hope St and Bostock St before reaching Stevens St. The boundary then follows Stevens St before moving north down the centre of Montreal St, before moving east along High St until Earl St. The

## **BUNBURY**: +1

RATIONALE: An approximate over allotment of 1000 voters will be allocated from the neighbouring Collie-Preston electorate.

BC: The boundary change will see the suburb of Pelican Point change electorates, the boundary hugging the coast to the west of Pelican Point, before hugging the western boundary of the Sanctuary Golf Course. The boundary will then move along the Bunbury Railway, before moving east along the SA1 boundary to the current electorate boundary.

#### **BURNS BEACH: -**

LOGISTICS: While this electorate is at quota, it is the logical electorate to take on the excess 7500 voters from the Butler electorate. An additional 7500 voters can then be distributed to the neighbouring Joondalup electorate to assist with under allotments in other coastal electorates.

BC: The southern boundary of the electorate will now move north along the Mitchell Fwy from Burns Beach Rd rather than south. The boundary will then move west along the southern boundary of SA 5110103, before moving south down the middle of Marmion Ave, before following the existing boundaries to the west along Burns Beach Rd and Ocean Rd through to the Indian Ocean.

The electoral boundary will move north along the centre of the Mitchell Fwy from Hester Ave, before moving west along the centre of Lukin Dr. The boundary will then move north along Marmion Ave rejoining the current boundary.

#### **BUTLER**: +7.5

LOGISTICS: An estimated over allotment of 7500 voters will need to be alleviated. With the northern boundaries proving an effective blocking of Perth 'suburbia', the logical changes are to the southern boundaries. The proposal will see the suburb of Ridgewood moved to the Burns Beach electorate.

BC: The boundary change proposed is to move the current boundary that runs through the centre of Hester Ave and move the boundary north. The boundary will now run through the centre of Lukin Ave, continuing in a straight line through to the boundary at the corner of Nowergup and Wanneroo Rd.

RATIONALE: While it is estimated that the electorate is on quota, the electorate will move further north to assist with under allotments in the electorates of Victoria Park and South Perth

# CARINE: -

RATIONALE: While Carine is on quota, the boundaries will move further north to ensure the excess in the far north suburbs is addressed. Around 2500 voters will be gained from the Hillarys electorate, while approximately another 2500 voters will be redistributed to the Scarborough electorate.

BC: The northern boundary will take in a section of the suburb of Padbury. The boundary will branch north from Hepburn Ave, proceeding up the centre of Gibson Ave. The boundary will then move west down the centre of Giles Ave, before moving south down the centre of Marmion Ave. The boundary will then return to moving in a westerly direction along Hepburn Ave.

The southern boundary will branch off from Duffy Rd to the west, proceeding along the northern edge of Lake Karrinyup Country Club down the centre of North Beach Rd before moving south down the centre of Clement Dr, before moving in a westerly direction down the centre of Pascoe and Axebridge St through to Marmion Ave, before moving in a Northerly direction.

# **CENTRAL WHEATBELT**: -3.5

RATIONALE: The Central Wheatbelt electorate is approximately 3500 voters under quota. The electorate will lose around 2500 voters to the Moore electorate while gaining between 5000 and 6000 voters from the Roe electorate.

BC: The southern boundary for this electorate will now branch off from the current boundary down the eastern and southern edge of SA1: 5124704, the southern edge of SA1: 5124707 and the southern and western edge of SA1: 5124716 through to the current boundary. ## **CHURCHLANDS**: -2.5

RATIONALE: The electorate is approximately 2500 votes under quota. Due to the excess in the northern suburban electorates, the electorate will gain an extra 2500 voters from the its northern neighbour, the Scarborough electorate.

BC: The new boundary will move north down the centre of Huntriss Rd from the current boundary before moving east down the centre of Beatrice and Cedric Streets. The boundary will then continue south down the centre of the Mitchell Fwy.

BC: The electoral boundary along Beenyup Rd will now continue south until Rowley Rd, which it will move down in a westerly direction through to Wattleup Rd. # **COOLBELLUP** (WILLAGEE) -1.5

RATIONALE: The electorate of Willagee was somewhat disjointed, so the seat has been significantly altered. The suburb of Willagee now moves into the Booragoon(formerly Bateman) electorate, so the electorate will now be named Coolbellup. Approximately 9000 voters will be moved into the Coolbellup electorate, with approximately 7500 voters redistributed into the Booragoon electorate.

BC: The southern boundaries of the electorate will now run down the centre of Beeliar Dve, starting at the Mandurah railway line. The boundary will continue through to Mayor

Rd before moving north down the centre of Hamilton Rd. The boundary will then run west along Amity Ave, before following the SA1 boundary to the ocean. The northern boundary now runs along South St, starting in the west at Stock Rd through to the Kwinana Fwy to the east.

# **COLLIE-PRESTON**: +1.5

(6 to Roe, 2.5 from Murray-Wellington, 1 from Bunbury, 1 from Vasse)

RATIONALE: The Collie-Preston electorate is around 1500 voters over quota. Around 6000 voters will be redistributed to the Roe electorate, primarily from the Collie township. Despite losing the Collie township, a name change is not advised as the Collie River still features prominently in the electorate. 1000 voters will be gained from the over

quota Bunbury and Vasse electorates, as well as around 2500 voters from the Murray-Wellington electorate.

BC: The boundary will now branch off at Warton Rd in a southeast direction along Bronzewing St, before moving northeast through the centre of Balfour St. The boundary will then move in a southeast direction down Corfield St to rejoin the current boundary. # COTTESLOE: +1

RATIONALE: The electorate being approximately 1000 voters over quota will be alleviated by redistributing voters to the neighbouring eastern electorates. The choice to move voters east rather than North occurs due to the creation of the new Ellenbrook electorate.

BC: The change to the boundaries occurs to the east of the electorate, branching in from Brockway Rd. The boundary will now run down the centre of John XXIII Avenue, before moving in a westerly direction down Moore Drive. The boundary then moves in a

southerly direction down Pine Tree Ln, Labella St and Montgomery Ave, before moving in an easterly direction down the centre of Alfred St back to Brockway Rd.

LOGIC: A new electorate of Ellenbrook is proposed. This is a growth area and will allow for this large suburb to function in the one electorate. This will also address the over allotment of Perth suburban seats in comparison to rural seats when the LDA is accounted for. This seat will effectively be a replacement for the significantly under quote electorate of North-West Coast.

BC: The centre of Maralla Rd will serve as the electorates Northern boundary. The boundary moves south down the Tonkin Hwy, moving east down The Promenade before moving south down Drumpellier Dr. The boundary then moves east down the centre of Park St, before moving south down the centre of Partridge St. The electoral boundary then follows the SA1 boundary along Woollcott Ave, north along West Swan Rd and east along Douglas Rd until reaching the Swan River. The boundary then moves north along the Swan River before reaching the Great Northern Hwy, where it continues is a Northern direction. The boundary then moves west along the walking trail to Ellenbrook Rd in front of the speedway, before moving south to Maralla Rd and the start of the electorate.
