

# WA LIBERAL PARTY SUBMISSION TO THE 2023 REDISTRIBUTION OF WESTERN AUSTRALIAN ELECTORAL BOUNDARIES

## Summary

There are currently 43 metropolitan districts and 16 country districts in WA. The enrolment statistics provided by the Commission provide no justification for altering this current balance. Provided there are sensible boundary changes to some districts where necessary, all existing 59 districts can continue to be represented in Parliament.

The Government's 2021 broken promise regarding Legislative Council regions, which reduced regional parliamentary representation, caused significant controversy. It would be implausible for the Commission to recommend the further breaking up of regional communities-of-interest by abolishing a country district, when no such decision is required.

Of the 10 districts outside the permissible enrolment limits, there is no cluster of three or more districts in either the metropolitan or country areas. Thus, there is no need to abolish a district or create a new one. This submission shows how surplus enrolments can be transferred to successive neighbouring districts, ensuring that all districts are retained. The only exception in the Liberal Party's submission is that boundary changes would mean that Collie-Preston needs to be renamed 'Preston', and that Willagee would need to be renamed 'Bibra Lake'.

The WA Liberal Party expresses its sincere gratitude to Mr Jeremy Buxton, who drafted this submission on our behalf.

## Recommended Boundary Changes

The Liberal Party has adopted a firmly incremental methodology in this submission. Current enrolments enable the continuance of 16 non-metropolitan districts, and 43 districts enclosed by the official Metropolitan boundary.

While we are aware that the Distribution Commissioners are empowered to cross this Metropolitan boundary, we submit that it delineates communities of interest, particularly on its northern side.

There is no justification for the creation of an additional metropolitan district, as those districts departing more than 10.0% from Average District Enrolment ("ADE") do not form a cluster but are generally spread across the outer northern and southern suburbs.

- Essentially these surplus enrolments can be transferred to successive neighbouring districts without grossly altering the character of any district.
- With no need for six districts to absorb or cede enrolments, their boundaries are recommended to be unchanged.

- In this submission no district will be abolished, although the districts of Willagee and Collie-Preston would require to be renamed because of the recommended transfer of eponymous localities.
- This submission seeks to avoid the splitting of localities, although it is not always possible to avoid splitting large localities like Canning Vale that are bisected by major roads. We have attempted to use connecting roads where larger localities are split.
- We are also proposing to reunite the split localities of Scarborough, Bayswater, Caversham, Ellenbrook, Lake Coogee, South Lake, Spearwood, Cooloongup, Wellard, Baldivis, Kensington, Wilson, and Leeming.

Where practicable these proposed boundaries have been aligned with local government boundaries, so that the eastern section of the City of Fremantle is proposed to be included in the district of Fremantle; the proposed district of Kwinana is co-extensive with the City of Kwinana; and the three districts of Rockingham, Baldivis and Warnbro are all contained within the City of Rockingham with only minor overlaps.

- The only non-metropolitan LGAs which continue to be split are the Cities of Mandurah and Greater Geraldton, and the Shires of East Pilbara, Harvey and Capel.
- The Shires of Augusta-Margaret River and Donnybrook-Balingup are each reunited within a single district, and the proposed district of Vasse is co-extensive with the City of Busselton.

In the next Parliament there will of course be no designated representation for non-metropolitan electors in the Legislative Council. The Liberal Party therefore considers that it would be most inopportune to further reduce non-metropolitan representation by the abolition of another district, particularly one covering rural, mining, pastoral and remote communities.

The provisions of the Large District Allowance (“LDA”), and the 20.0% tolerance for districts with LDA, remain in the *Electoral Act 1907* and the Liberal Party submits that they should be fully utilised to maintain the eight districts that have previously formed the Agricultural and Mining and Pastoral Regions of the old Legislative Council.

- Use of LDA to bring the four districts of the former Mining and Pastoral Region within quota involves the transfer of only 720 electors.
- We are unable to specify the exact proposed boundary between the proposed districts of Kimberley and Pilbara that would result in the gain of around 1500 LDA by Kimberley, as such data is unavailable.

While considerable use has been made of the 10.0% tolerance from ADE (extending to – 20.0% for districts with LDA), only two proposed districts have enrolments falling within 2.5% of either upper or lower limits.

- We submit that it is desirable to maintain the current boundaries of the district of Geraldton (with Albany and Bunbury also unchanged).
- Rather than split a locality, the proposed district of Bicton with its record of slower growth has been given a relatively high initial enrolment.

Overall, it is proposed that 30,603 electors in current non-metropolitan districts will be transferred to other districts – 7.0% of enrolments.

- Within the 43 proposed metropolitan districts, 123,793 electors would be transferred, 9.1% of total enrolments.
- Altogether more than 92.0% of Western Australian electors would remain within their current district.

The Liberal Party maintains that State electoral districts should continue to have geographic names, a practice that distinguishes them from Federal divisions. The proposed boundary changes would require the renaming of Collie-Preston and Willagee.

- It is suggested that the former district be named Preston.
- Bibra Lake could be suitable names for the current Willagee district.

### Individual District Changes

Below are the WA Liberal Party's proposed boundary adjustments for all 59 electoral districts. For ease of use, electoral districts have been listed alphabetically within a Country or Metropolitan category.

These adjustments show that the retention of all existing 59 districts is possible, enabling the continuance of 16 country districts, and 43 districts enclosed by the official Metropolitan boundary.
